BOARD VACANCY ANNOUNCEMENT

The general public of the Borough of Red Bank is hereby notified that there is a vacancy on the Red Bank Regional High School Board of Education representing the Borough of Red Bank. It is the intention of the Board of Education to fill this vacancy as soon as possible, potentially at the October 1st Board meeting. The appointment shall be through December 2025, after which point the seat will be filled through the election process.

In accordance with New Jersey State Law, those persons interested in serving as a member of the Board of Education shall have the following qualifications:

- A U.S. citizen,
- A resident of the Borough of Red Bank for at least one year,
- A registered voter in the district and not disqualified as a voter pursuant to NJSA 19:4-1,
- Must not hold office as mayor or membership in the municipal governing body,
- Is at least eighteen (18) years of age,
- Must be able to read and write,
- Not be directly/indirectly interested in any contract with or claim against the Board, and
- Not have been convicted of a crime or offense as listed in NJSA 18A:12-1.
